STIPULATED SCHEDULING ORDER

The parties in the above-styled matter have conferred and believe that the issues presented in this matter may be resolved by the Court pursuant to cross-motions for summary judgment or other


dispositive motions. The Court has scheduled October 26, 2011, for trial of this cause. Accordingly, the parties have stipulated to the entry of this Scheduling Order, as follows:

1. The parties shall complete any discovery on or before August 31, 2011.
2. The parties shall file motions for summary judgment or other dispositive motions on or before September 12, 2011, along with any documents or affidavits relied upon.
3. Defendants do not need to file further pleadings in answer or response to the complaint.
4. On or before October 11, 2011, each party may file its response to any motion for summary judgment or other dispositive motion filed by any opposing party.
5. The claims against the defendant Jeff Atwater in his official capacity as Chief Financial Officer of Florida are dismissed pursuant to Rule 1.420(a)(1), Fla. R. Civ. P., but CFO Atwater remains a defendant in his capacity as a member of the State Board of Administration.
6. Plaintiffs withdraw their request for class certification and any class representation allegations, references to any class, and requests for relief on behalf of any class made in the Complaint will be deemed dismissed pursuant to Rule 1.420(a)(1), Fla. R. Civ. P.


